Upon acceptance, a \$1,000 non-refundable payment toward tuition is required no later than December 8, 2023. Unless special arrangements have been made with the CEO, remainder of tuition must be received in full prior to the opening retreat. Full Tuition payment is expected by January 5, 2024. |
